Terms and Conditions of Sale – Updated March 2025

Please read all Terms and Conditions carefully.

Payment & Order Terms

- i. First orders are pre-paid only. Account Open subject to Credit Check & References.
- ii. Minimum order to receive credit terms is £100.00 / €100.00 orders below this value are pre-paid only.
- iii. 30 days payment terms will be at Goodman Bros discretion and can be removed anytime.
- iv. Goodman Bros or representatives of the company shall be permitted to enter the premises of a customer to repossess goods, if necessary, in the event of non-payment. All Goods remain the property of Goodman Bros until paid in full. This includes the Perma Jewel display boards. These will remain property of Goodman Bros until such time the customer is no longer a stockist.
- v. All overdue accounts will incur interest at 2% per month on the overdue balances.
- vi. In the event of non-payment, all outstanding invoices will be passed to our Debt Collection company.
- vii. Unless by prior, written agreement Goodman Bros do not supply goods on a sale or return basis.
- viii. Stripe Card Payment are subject to a 0.5% fee.
- ix. Cheques are not accepted as payment.

Bespoke Terms

- i. All Bespoke orders will require a signature of approval and confirmation of order.
- ii. Bespoke orders cannot be returned for any reason other than for manufacturing fault.
- iii. 50% payment may be required for Bespoke goods at Goodman Bros discretion.
- iv. All Bespoke Items Remain the property of Goodman Bros until paid in full.
- v. Any Bespoke goods agreed to "call off" are payable in full if customer chooses to cancel order.

Standard Delivery Terms

- i. Postage & Packaging: Standard: £10 | €10 - All orders under £500 | €500 value.
- ii. Orders exceeding £500 | €500, with a standard service will be shipped free of charge.
- iii. Our Standard delivery Times are to dispatch goods within 24 hrs from receipt of order.
- iv. Cut off for Next Day Orders is 12pm.
- v. Branded or bespoke orders, delivery terms will be agreed in advance and on order confirmation.
- vi. Any damages / shortages should be reported within 48 hours of receipt of goods.
- vii. Goods not received within 7 days of confirmation email to be reported within 48 hours of the 7 days. Failure to do so may result in the stores liability for missing order.

Orders Outside of UK

- i. Orders for delivery outside of the UK, freight will be calculated and applied once order placed.
